

Vice Governor Oyo Uy marks 38th birthday through 'Araw ng Pasasalamat' By: Jan Fhore Andrey L. Cagalitan

Regarded as the youngest Vice Governor in the Province of Davao del Norte, Vice Governor De Carlo "Oyo" L. Uy celebrated his 38th natal day with the residents of Brgy. Igangon, San Isidro, through the monthly caravan of services dubbed "Araw ng Pasasalamat" conducted by his office. Although his birthday falls on the 12th day of January, Vice Governor Oyo Uy decided to celebrate his special day a day earlier (January 11) and kick-start the new year by bringing social services programs to remote communities.

During the fourth round of "Araw ng Pasasalamat," five (5) programs were brought by the Vice Governor's Office to the residents of Brgy. Igangon, San Isidro, namely:

- Tambag Legal: aims to provide free legal consultation at the grassroots level;
- 2. **Medical Mission:** aims to deliver free medical assistance, such as free check-ups, consultations, and medicine, to the barangay residents (in partnership with Tagum

City Health Office, Barangay Igangon Health Workers, Metro Gear Construction Corporation, and Davao Metro Shuttle);

- 3. Handog Titulo: aims to fasttrack the disposition of untitled lots and processing of public land titles through residential and agricultural free patents for the identified beneficiaries partnership with the Department of Environment and Natural Resources, Land Authority-Registration Registry of Deeds, Provincial Environment and Natural Resources Office. and the Provincial Assessor's Office);
- 4. **Libreng Gupit:** aims to provide free haircuts to those who wish to avail of the program and defray the cost of extra expenses whenever they need to go out of their community just to cut their hair (brought by former Ex-Officio Member/PCL President, Tristan Royce

"Bong" Aala); and,

 Libreng Lugaw: aims to provide free porridge to event participants (brought by District 1 Board Member, Hon. Robert "Tete" So).

Free meals were also provided for everyone who attended the event. VGO staff surprised Vice Governor Oyo Uy with a birthday cake, and a mascot who performed and made the event participants, especially the children, amused. Likewise, loot bags and sets of toothbrushes and toothpaste were distributed by Vice Governor Oyo Uy himself to toddlers and schoolchildren present during the event.

In his Facebook post, Vice Governor Oyo Uy thanked his staff and partner agencies and personalities who provided support in conducting the one-day activity. "Sama sa akong ingon, usa ka blessing gyud nga makauban ug mahatdan kamo (mga residente sa Brgy. Igangon, San Isidro) ug social services. It was indeed an early birthday gift na makauban ang katawhan," he added.

The Sangguniang Panlalawigan of Davao del Norte for term 2022-2025, headed by Vice Governor and Presiding Officer Hon. De Carlo "Oyo" L. Uy, MBA, has passed four hundred sixty-one (461) resolutions and twenty-one (21) ordinances, itemized as (5) Appropriation Ordinances and (16) Provincial Ordinances for six (6) months from July 1, 2022 to December 31,2022.

The Honorable Vice Governor "Oyo" Uy presides over the session that maintains order and decorum, recognizes every member to speak, and enforces the house rules, practices, and precedents of the session. In six (6) months since he took his oath of office, he never failed to attend a single legislative session as he is one who had a perfect attendance in the legislative body, followed by Hon. Emmanuel G. Pamisaran, Hon. Shirley Belen R. Aala, and Hon. Emerson Dave A. Silutan. Likewise, Vice Governor Uy authored the Freedom

Orly A. Amit of 2nd District, representing the Island Garden City of Samal, leads as top performing SP Member who authored/sponsored the most number of resolutions (375), appropriation ordinances (2) and Provincial Ordinances (14), followed by Hon. Emmanuel G. Pamisaran also of 2nd District with resolutions (354), appropriation ordinances (3), provincial ordinances (14), in the 3rd spot is Senior Board Member

Honorable Flopone Royle A. Catalan of 2nd District with resolutions (354), appropriation ordinances (2) provincial ordinances (8), Hon. Shirley Belen R. Aala of 1st District is on the 4th spot with resolutions (343), appropriation ordinances (3), provincial ordinances (9), while the Majority Floor Leader Hon. Robert L. So of 1st District, entrepreneur and second termer SP Member, is occupying the 5th spot who authored/sponsored (271) resolutions, appropriation ordinances (2) and provincial ordinances (12) covering the period of July 2022 to December 2022.

While the five areas of legislations, such as Governance, Administration, Environmental Management, Social Services and Economic Development have been judiciously acted by all Sangguniang Panlalawigan Members with a 100% legislation whose individual inputs has considerably contributed to the attainment of remarkable legislative outputs for six (6) months.

Vice Gov. Oyo Uy highlights SP's CY 2022 accomplishments

Vice Governor De Carlo "Oyo" L. Uy, MBA presented the highlights of the Calendar Year (CY) 2022 accomplishments of the Legislative Department in the latter's Legislative, Quasi-Judicial and Oversight Functions during the Privilege Hour of the 6th Regular Session of the Sangguniang Panlalawigan (SP) held last February 6, 2023, after temporarily relinquishing his Chair to Senior Board Member, Hon. Flopone Royle A. Catalan.

Foremost in the Vice Governor's presentation is the SP's performance of its Legislative function covering the various areas of Legislation. Counting from the onset of their Term, in a period spanning six (6) months, the SP had already passed four hundred sixty-one (461) resolutions itemized into the following areas: Social Services twenty-nine (29); Economic Development twenty-seven (27), Environmental Management - one (1), Governance - one hundred (100); and Development Administration - three hundred twenty (320). The mentioned Areas are further classified into sub-sectors: Social Services (Health Care Access, Housing, Basic Education, Family Care, Youth Development, Peace and Order, Disaster Risk Reduction and Management and Relief for Individuals in Crisis Situation); Economic Development (Agriculture and Fisheries Development, Business Enterprise Development and Industrial Promotion); Environmental Management (Pollution Control and Environmental Protection); Governance (Accountability and Transparency, Public Participation and Satisfaction and Equity); and Development Administration (Development Planning, Revenue Generation and Management and Human Resource Development). Further, twenty-one (21) ordinances were enacted by the working legislators for the second half of the year

Among the notable legislations enacted in CY 2022 include the following: Resolution No. 781 authored by Honorable Shirley Belen R. Aala which encourages the installation of

Closed-Circuit Television (CCTV) Cameras in strategic places in all Local Government Units (LGUs) in the Province; Katipunan ng Kabataan (KK) Assembly Days in all barangays of the Province, the Topnotchers and Medalists Incentives Ordinance and the Gender and Development Code all authored by Hon. Emerson Dave A. Silutan, LPT; The Revised Children's Welfare Code authored by Hon. Jannet N. Tanong-Maboloc; Grace Period to all Property Owners of the LGUs of Asuncion, New Corella and Tagum City in the payment of Real Property Taxes for the first and second quarter of CY 2022 without penalty until paid on or before July 31, 2022, as well as the Granting of Relief on the Payment of surcharges and interests on local tax on transfer of Real Property ownership until June 14, 2023 both authored by Hon. Flopone Royle A. Catalan; Provincial Cultural Communities Affairs Office Ordinance authored by Hon. Ariel S. Macla; Revised Provincial Cooperative Development Council (PCDC) Ordinance, Livelihood Financing Assistance Programs Ordinance and Provincial Agricultural and Fisheries Council (PAFC) Ordinance all authored by Hon. Emmanuel G. Pamisaran; Creation of Persons with Disability Affairs Division authored by Hon. Nicandro T. Suaybaguio, Jr., UAP; Accredited Volunteer Barangay Sanitary Inspector (BSI) Financial Assistance Accredited Barangay Health Workers (BHWs) Financial Assistance, Accredited Schisto Control Workers Financial Assistance, Granting Financial Assistance amounting to Five Thousand Pesos (Php5,000.000) per annum to Rapid Diagnostic Test Volunteers and Araw ng Barangay Financial Assistance all authored by Hon. Orly A. Amit and the Freedom of Information Ordinance authored by the Vice Governor himself.

For its Quasi-Judicial Function, the Sangguniang Panlalawigan convened as a Quasi-Judicial Body and conducted various Quasi-Judicial Hearings for the purpose of the disposition of Administrative Case No. 2021-001 and thereafter adopted a Decision

prepared by the SP's lone lawyer and designated ponente thereof, Hon. Devona H. Jumamil, as embodied in Resolution No. 672, Series of 2022.

Featured also in the aforesaid presentation are some of the myriad of activities spearheaded by the provincial legislators in adherence to their Oversight functions as stipulated in Republic Act No. 7160 otherwise known as the Local Government Code of 1991, such as the conduct of the Inaugural Session; the 2nd Provincial SK Summit; Consultation with Ferry Operators to Resolve Traffic Woes to and from Samal Island; 3rd Liga ng mga Barangay Congress; Legislative Summit, Philippine Councilors League (PCL) Week Community Outreach Programs; Executive-Legislative Agenda (ELA) Consensus-Building and Finalization; Tambag Legal Outreach Activity of PROJECT OYO; 9th Indigenous Peoples (IP) Summit and the Vice Governor's Office (VGO) Caravan of Services.

Vice Governor Uy emphasized the legislations concerning the agriculture sector of the Province. "Nangita pod ta'g mga pamaagi nga makabuhat ta'g programa para ikatabang sa atuang katawhan sa Davao del Norte...when it comes sa atuang mga farmers, naa tay ordinansa nga napasa... si Board Member Mawe Pamisaran pa gani ang maoy ning author ato ug ni-head ato, ug ning-defend which is Livelihood Financing Assistance Programs Ordinance of the Province of Davao del Norte. And at the same time, Provincial Agricultural and Fisheries Council Ordinance for the Province of Davao del Norte."

"Kami diri sa Sangguniang Panlalawigan is a working Sangguniang Panlalawigan and we will exercise to the utmost of our abilities, maningkamot gyod mi para modeliver dili lang in parts of legislation but in all our functions and as a public servant para ma-deliver pa gyod kung unsa ang pwede namong matabang sa katawhan...," Vice Gov Oyo Uy pledged to the constituents of the Province.

SP speaks unity in its sponsorship of the Monday **Convocation** By: Iris P. Temperatura

On the first Monday of the month of love, the Sangguniang Panlalawigan, headed by Vice Governor De Carlo "Oyo" Uy, sponsored the monthly convocation of the Provincial Government of Davao del Norte last February 06, 2023 at the DavNor Gym. Major legislations and beyond-legislation accomplishments of the Legislative Department were highlighted in the said event. Since the assumption of office of the new set of elected officials for Term 2022 to 2025, the August Body has passed four hundred sixty-one (461) resolutions and twenty-one (21) ordinances in just a span of six months, and has approved one hundred ninety-seven (197) resolutions in January of Calendar Year 2023.

Several remarkable and laudable pieces of legislation passed by the Sangguniang Panlalawigan that was reported during the said convocation are as follows: (1) Appropriation Ordinance No. 2022-**005**, which is the approved budget of the Province of Davao del Norte for 2023; (2) Provincial Ordinance Nos. 2022-014, **2022-015, 2022-016 and 2022-017**, all relative to the financial assistance extended by the Provincial Government to its various barangay functionaries; (3) Provincial Ordinance No. 2022-019, the Freedom of Information Ordinance of the Province of Davao del Norte authored and filed by the Head of the Legislative Department, Vice Governor Oyo Uy, which aims to value the right of the Dabaonon people to an open and transparent governance; (4) Provincial Ordinance No. 2022-020, the grant of financial assistance to every barangay of Davao del Norte for its celebration of Araw ng Barangay which was originally in the amount of Twenty-Five Thousand Pesos (PhP25,000.00) but was increased to Fifty Thousand Pesos (PhP50,000.00) through the initiative of Board Member Orly A. Amit, being the main author of the said ordinance; (5) Appropriation Ordinance No. 2022-007, the grant of additional incentives to all the employees of the Provincial Government of Davao del Norte in the total amount of Thirty-Nine Million Pesos (PhP39,000,000.00); **(6) Provincial** Ordinance No. 2022-012, institutionalizing the Provincial Agricultural and Fisheries Council (PAFC) of the Province of Davao del Norte; (7) Provincial Ordinance No. 2022-**004**, the Revised Children's Welfare Code of the Province of Davao del Norte; and (8) Provincial Ordinance No. 2022-018, the Revised Gender and Development Code of the Province of Davao del Norte.

Additionally, the Legislative Department also reported its significant

Every Monday, nagaoath gyud ta og atoang Lingkod Bayan, and I hope, as your fellow government employee, isip usa pod ka trabahante sa gobyerno—ang lamang lang nako karon kay ako ray naggunit sa mic pero kung buot hunahunaon pareha ra man ta ninyong tanan. Naglahi lang atong opisina og designation. Kinahanglan lang siguro nga ma-remind ta everyday and mga pulong nga atoang ginalitok everytime sa atoang Oath of katong Lingkod Bayan, importante to [nga] mga pulong. Kinahanglan nato to timan-an og dili nato to sya kalimtan. So, kana lang. I'll just make this short kay kabalo ko daghan pa og atimanonon ang inyong opisina. Among opisina didto ron, daghan pang solicitations nag-atang, may man mo. So, kana lang, magpadayon lang ta sa atong pagtrabaho. Hinaot nga aduna tay fruitful week ahead of us, fruitful days ahead of us. Padayon lang ta sa pagserbisyo og paghimo og tama sa atong trabaho. And rest assured that our Sangguniang Panlalawigan through the leadership of Vice Governor De Carlo Oyo Uy magpadayon sa usa ka empowering, participatory, open and transparent Panlalawigan alang Sangguniang katawhan sa Davao del Norte. Kanatong tanan, maayong buntag. God bless us all og advance Happy Happy Valentines Daghan kaayong kanatong tanan.' salamat." 🖆
