Finding a leader who gives equal importance to both is essential in thriving communities and blessed is the province to have a Vice Governor that does just that.

One of the programs that Vice Governor Rey T. Uy holds close to his heart is the Shelter Assistance Program. This program started when he was still serving as Mayor in Tagum City. Just like any padre de pamilya who wants a safe space for his children, Vice Governor Rey T. Uy's aim for this program is to provide a respectable home to families within the province. In partnership with the Metro Gear Construction Corporation as encouraged by the Public-Private Partnership (PPP) legislated by SP DavNor, this program has helped 150 households this fiscal year, proving that when the government and the private sector work hand in hand, this can be able to accomplish more and serve better.

This desire to help make the lives of his constituents comfortable has been a longstanding commitment of Vice Governor Uy and his family. Even when he was still serving as City Mayor, he has established nine (9) relocation sites in the following areas: Suaybaguio 1 - Apokon, Suaybaguio 2 - Apokon, RTU Village - Apokon, Sto.

Rosario Village - Apokon, Wakan - San Isidro, Laureta Homes - San Miguel, Fe Village - Mankilam, Iga Uy Village -Madaum, and Busaon Village. Aside from assistance in housing, Vice Governor Rey T. Uy is also adamant in maintaining cleanliness and quality of roads, not only for beautification purposes but also for ease of use for constituents and for travelers from outside the province. Whether elected in a government office or not, the Uys continue to serve many through their numerous corporate programs.

Anotherinfrastructure accomplishment of the Office of the Vice Governor is the gravelling of over 65 roads and provision of construction materials to 95 beneficiaries across the province of Davao del Norte. While some consider infrastructure as less important, the leadership of Vice Governor Rey T. Uy acknowledges that it is vital in achieving economic growth.

The pandemic has posed a challenge not only to huge corporations but more so for many families within the province. Seeing the need to support many affected families in the province, Vice Governor Rey T. Uy partnered with TINGOG Partylist, TURISMO Partylist and Department of Labor and Employment (DOLE) to implement the TUPAD (Tulong Panghanapbuhay sa Ating Disadvantaged/ Displaced Workers) Program which served 330 beneficiaries within Davao del Norte; the goal of which is to assist and support

the livelihood of workers who lost jobs during the global pandemic. Added to this are the 300 beneficiaries of the AICS (Assistance to Individuals in Crisis Situation), which has similar objectives to the TUPAD Program. Filipinos are known for strong family ties and Vice Governor Rey T. Uy is pleased to help these individuals because in providing support to them, he is also supporting many families to stay afloat during this challenging time.

In his drive to create a more inclusive province, the Office of Vice Governor Rey T. Uy has also distributed assistive devices to our differently-abled constituents. It can be confirmed that Vice Governor Rey T. Uy has served 470 beneficiaries by providing wheelchairs, canes, quad canes, and walkers. Though it cannot aggressively push for new programs due to stricter protocols, the Office of the Vice Governor continues to think of ways to support and enrich the lives of differently-abled Dabaonons.

The challenges brought by the pandemic these past two years has revealed not only the strengths but even weaknesses. It also showed the abilities of the true leaders and this can be seen that Vice Governor Rey T. Uy has remained firm in his commitment to serve and lead regardless of the difficulties, always exemplifies Aksyon Agad.

Province Of Davao del Norte Declares State Of Calamity By: Leilanie A. Degracia

The Province of Davao del Norte has declared a state of calamity due to incessant rains caused by shear line weather system beginning Saturday morning, 15 January until Monday 17 January 2022 which major rivers of Libuganon and Saug swelled and resulted to flooding of low-lying areas of Asuncion, Kapalong, Braulio E. Dujali, Tagum City, New Corella, Santo Tomas, Carmen and landslides to the Municipality of Talaingod.

Based on the report of Rapid Damage Assessment and Needs Analysis (RDANA) team as of January 20,2022, the flood adversely affected thirty-six (36) barangays displacing one thousand three hundred five (1,305) individuals or four hundred eighteen (418) families from a total of sixty-three thousand nine hundred sixty seven (63,967) affected population and brought damages to agriculture worth Seventy-Six Million One Hundred Sixty-Four Thousand Eight Hundred Seventy Eight and 90/100 Pesos

(₱ 76,164,878.90).

With the adverse effects brought by the calamity to the population and properties, the Sangguniang Panlalawigan of Davao del Norte conducted its 1st Special Session recently on Wednesday January 26, 2022 for the passage of Resolution No. 097, Series of 2022 "Declaring the Province of Davao del Norte under the State of Calamity" as recommended by the Provincial Disaster Risk Reduction and Management Council (PDRRMC) through the issuance of Resolution No. 1, Series of 2022.

The declaration will hasten the rescue, recovery, relief and rehabilitation efforts of the Province and the Private Sector, including the humanitarian assistance to facilitate the provision of emergency services to the displaced individuals/families and likewise will effectively control the prices of basic goods and commodities in the affected areas in accordance with pertinent operational plans and directives.

The Chairperson of the Committee on Tourism of the Sangguniang Panlalawigan, it is BM Janet Tanong-Maboloc's duty to craft and upgrade laws that are needed for the operation of the tourism industry. Through Provincial Ordinance No. 2021-007, entitled "The Revised Tourism Code of the Province of Davao del Norte," some provisions of the Provincial Tourism Code of Davao del Norte CY 2014 are needed to be updated to attune for the changing times especially tourism recovery and resiliency plan from the Covid-19 Pandemic because even the Department of Tourism has amended its policies and guidelines pertaining to the tourism industry to readily address different issues and concerns.

The Revised Tourism Code of Davao del Norte is designed for both inbound and outbound tourist and tourism service providers. Its policy is to be taken as a guide to the proper manner of conducting tourism operations and activities. All portions and provisions of the new tourism code are revised to adopt a more responsive approach to aggressively promote the tourism industry in the province amidst the Covid-19 pandemic.

"Ang responsibilidad nato sa katawhan, tulobagon nato sa Kahitasan," mao ang baruganan ni Board Member Datu Ariel Serapio Macla, ang kasamtangang represenante sa Indigenous People sa tibuok probinsya sa Davao del Norte sa Sangguniang Panlalawigan. Ang iyahang posisyon mas naila isip Provincial IPMR kon Indigenous Peoples Mandatory Representative, diin nagtugot ang balaod nga ma-representahan ang sektor sa IPs sa tanang legislative bodies sa lokal nga panggamhanan, lakip na ang probinsya.

Nitibo sa Panabo City, niining probinsya, gipanganak si Datu Macla atong Disyembre 12, 1970 sa Barangay Datu Abdul sa maong syudad. Giila nga matinumanon sa iyahang mga ginikanan si Datu Macla gikan pa sa iyang pagkabata, ug labing mapalanggaon sa iyahang inahan nga si Loreta Serapio Macla nga lumad sa Mabuhay, Paquibato District, Davao City. Gibilin usab sa iyahang amahan nga si Carlito Mayato Macla ang mga kinaiya sa usa ka-lider, diin matud niya sagad nang ginaduol sa mga kasilinganan iyang amahan panahon sa adunay mga problema sa komunidad.

Nakahuman sa elementarya ug hayskul si Datu Macla sa Maryknoll College of Panabo, ug mipadayon sa kolehiyo sa University of Mindanao sa Davao City. Human sa mubong higayon, naminyo si Datu Macla sa usa

ka-rehistradong midwife nga si Emma Ranain, ug nabuligan sila og tulo ka-anak, mao sila Norhayya Macla-Mocsanat, usa ka-Certified Public Accountant (CPA); Mohammad Nassefh R. Macla, usa ka-UP graduate, magbabalak, ug rehistradong maestro; ug Yusoph Habeeb R. Macla, kasamtangang nagahuman sa iyahang Senior Highschool.

"Born to lead gyud si ama," sigon ni Nassefh, ang ikaduha sa tulo ka-managsuon ni Datu Macla. Mahinumdoman nga mi-serbisyo sulod sa 13 ka-tuig si Datu Macla isip kagawad sa Barangay, bag-o kini mapalaran mamahimong IPMR sa syudad sa Panabo. Sa iyaha usab nga nag-inusarang termino isip City IPMR, nakabuhat si Datu Macla og mga landmark legislations sama sa pagmugna og kasaulogan sa Buwan ng Tribu, pag-establisar sa City Cultural Communities Affairs Office, ug ang Revised Traffic Code sa Panabo. Katambayayong ni Datu Macla si Nassefh sa pagpanday sa maong mga balaudnon, diin gihimo niya kining Chief of Staff sa opisina.

The Barangay Tanod, created under the Local Government Code of 1991, specifically Chapter 2, Section 387 (b), has an indispensable role in the local government unit specifically in the maintenance of peace and order and the promotion of public safety within the barangay. The said Ordinance shall cover not more than Twenty (20) Barangay Tanod in Two Hundred Twenty-Three (223) barangays of the province that are duly appointed by the Punong Barangay upon the recommendation of the Barangay Peace and Order Committee (BPOC).

Barangay Tanod brigades were organized to assist the government in the maintenance of peace and order in the country. Pursuant to such duty, they conduct rondas or nightly patrols, necessarily exposing their lives and limbs to dangers in the hands of criminal elements and other wayward members of society. Peace and order in local communities translates to a sense

of a shared feeling of security among the citizens. Thus, people who have this sense of security are more likely to participate in community activities that aim to improve the livelihood and well-being of all. In this sense, the maintenance of peace and order is part of the foundation for genuine, community-based development.

BM Parangan penned said ordinance in adherence to Chapter 4, Section 393 (d) of the same Local Government Code that provides "that all duly appointed members of the barangay tanod brigades or their equivalent, which number shall not be more than twenty (20) in each barangay, shall be granted insurance or other benefits during their incumbency, chargeable to the barangay of the city or the municipal government to which the barangay belongs."

Once earlier revoked for a valid cause by the Law & Order Council, their appointment may be renewed upon a favorable recommendation of the BPOC. 🌡
