## BM Popo Estabillo Jr. authors BANTAY ASF sa Barangay or "BABay ASF" Program in Davao del Norte

Caused by the pandemic, the ubiauitous economic activity of Swine Raising among Dabaonons has experienced a huge deficit brought about by the incursion of ASF (African Swine Fever) in the Province of Davao del Norte that has led to loss of livelihood source, food security threat and social displacement of hog raisers and piggery workers. This ASF disease has affected an estimated swine population of one hundred thirty-nine thousand one hundred eight (139,108) heads based on data of the Philippine Statistics Authority (PSA), that is one hundred thousand six hundred seventy-four (100,674) heads of backyard operations and thirty-eight thousand four hundred thirty-four (38,434) heads for the commercial operations.

Knowing the urgency to address the resurgence of ASF and mitigate its adverse impacts, Board Member Prospero "Popo" Estabillo Jr. immediately crafted an ordinance to jumpstart the rehabilitation of the local hog industry and to ensure the availability, adequacy, and affordability of pork products, all for the purpose of attaining food sufficiency and security in the province.

BM Estabillo, being the Chairperson of the Committee on Agriculture of the Sangguniang Panlalawigan, aided by Dr.

Rommel B. Montiel, Veterinarian IV, of the Provincial Veterinary Office of Davao del Norte, instantly conducted the New Normal Virtual Public Hearing of Provincial Ordinance No. 2021-010, entitled "Strengthening the Implementation of the Bantay ASF sa Barangay or BABay ASF Program in the Province of Davao del Norte," last November 23 to 26, 2021 for the (11) LGU's of Davao del Norte. Also invited and attended as direct respondents of the said virtual public hearing were the different City and Municipal Veterinarians, Agriculturist, SP Chairperson of the Committee on Agriculture of LGUs, Economic Enterprise Managers, ABC Presidents and Stakeholders who are engaged in pig farm industry in the province.

Dr. Montiel updated the LGUs on the various programs and interventions against ASF including the "Bantay ASF sa Barangay" and the accompanying hog repopulation program, the modified protocols in managing, containing and controlling the ASF, and livelihood assistance under the Program to ASFaffected hog raisers. BM Popo explained in the ordinance that an amount of at least Two Million Pesos (PhP2,000,000.00) shall be allocated annually for the Provincial ASF Task Force earmarked for personnel services, purchase of disinfectants,

disease monitoring and surveillance, indemnification in cases of outbreaks and printing of Information, Education and Communication materials. In any event of ASF outbreak, the Task Force will extend a financial assistance of at least Two Thousand Pesos (PhP2,000.00) per head of pig culled regardless of age with suckling piglets not included. Only a maximum of twenty (20) heads per farmer under a small-hold farm shall be paid off. Commercial farms are not included in the indemnification program. Only farmers enrolled under the Registry System for Basic Sectors in Agriculture (RSBSA) shall avail of the said assistance. The Task Force shall also extend provisions for livelihood activity like free-range chicken for affected farmers to recover from the economic losses of the outbreak.

BM Estabillo added that it would be stronger if they have the program implemented down to the municipal level, especially since the economy is starting to open. It seeks to create an effective ASF monitoring, surveillance, and reporting system, to intensify the practice of biosecurity measures in all hog farms, and to assist in recovering the hog industry. Nonetheless, BM Estabillo said that they continue to campaign for consumers not to buy pork products coming from places with ASF cases.

### **Incentive for Appointed Barangay Blood Program Coordinators** Okd, "they are unsung heroes"- BM Lu

The Sangguniang Panlalawigan of Davao del Norte, through the initiative of Board Member Denise Marianne A. Lu, MD, Chairperson of the Committee on Health and Social Services, unanimously approved Provincial Ordinance No. 2021-006, "Granting a Financial Assistance/ Incentive of Three Thousand Pesos (₱3,000.00) per annum to Appointed Barangay Blood Program Coordinators of Davao del Norte, defining the qualifications/functions thereof and appropriating funds for the purpose," approved on November 28, 2021 during the 45th Sangguniang Panlalawigan Regular Session.

The subject Provincial Ordinance intends to grant incentive to appointed Barangay Blood Program Coordinators that recognizes the services of the Barangay Blood Program Coordinators who are actively and regularly performing their duties, in their commitment for the sustainability of the Provincial Voluntary Blood Sufficiency Program of Davao del Norte.

The National Blood Services Act of 1994 (Republic Act No. 7719) promotes

and encourages Voluntary Blood Donation by its citizenry, rooted on the strategy which aims to provide adequate supply of safe blood under the National Voluntary Blood Services Program. The same law provides for the creation of the Local Blood Councils which shall spearhead the Local Blood Donation Program for the voluntary and non-profit collection of blood.

At present, there are two hundred twenty-three (223) Barangay Blood Program Coordinators (BBPCs) serving as frontliners in the delivery of Basic Health Services, particularly in the provision of safe, accessible and quality blood in their respective communities.

"Our Barangay Blood Program Coordinators, same with our Barangay Health Workers are our unsung heroes in this pandemic. These are the people who have been tirelessly working on the ground, so that government services may be able to reach our constituents who need it most in every Barangay especially in far-flung areas. They deserve this recognition and incentive," Dr. Lu said in an interview.

There will be a sufficient amount that shall be appropriated yearly under the Provincial Government's coffer and the financial assistance/incentive shall be paid in lump sum every December of each year to commence on December 2021 and every year thereafter in accordance with the usual accounting principles and auditing rules and procedures. 🛓
