EXECUTIVE ORDER NO. 25

RECONSTITUTING THE COMPOSITION OF CONSTRUCTORS' PERFORMANCE
EVALUATION SYSTEM - IMPLEMENTING UNIT (CPES-IU) OF THE PROVINCIAL
GOVERNMENT OF DAVAO DEL NORTE

WHEREAS, as mandated under Section 12 of Annex E of the Implementing Rules and Regulations (IRR) of R.A. 9184, otherwise known as Government Procurement Reform Act, all procuring entities implementing government infrastructures shall evaluate their contractors;

WHEREAS, all agencies shall conduct constructors' performance evaluation which shall be done during construction and upon completion of each government project adopting the Constructors' Performance Evaluation System (CPES) Guidelines;

WHEREAS, further mandated under R.A. 9184 is that each agency shall establish CPES-Implementing Unit (CPES-IU) responsible for the implementation of CPES Implementing guidelines including but not limited to the supervision of Constructors' Performance Evaluators accredited by the Construction Industry Authority of the Philippines (CIAP);

WHEREAS, pursuant to the provisions of R.A. 9184, Executive Order No. 18, series of 2014 was put into order to establish the Implementing Unit of the Constructors' Performance Evaluation System of the Province of Davao del Norte;

WHEREAS, with the assumption of the new Governor and recent change in the composition of its members, there is a need to reconstitute the composition of the CPES-IU;

NOW, THEREFORE, I, ANTONIO RAFAEL G. DEL ROSARIO, Governor of the Province of Davao del Norte, by the power vested in me by law, do hereby order the following:

Section 1. Reconstitution. There shall be a reconstituted Constructors' Performance Evaluation System-Implementing Unit (CPES-IU) of the Province of Davao del Norte;

Section 2. Office Set-Up. The CPES-Implementing Unit shall be lodged at the Provincial Engineer's Office (PEO) under the leadership and supervision of the Provincial Engineer, with Secretariat support from the PEO-Administrative Section. The Unit shall be manned by a inter-departmental CPES-Implementing Team to perform functions of the unit.

Section 3. Composition. The reconstituted CPES-Implementing Unit shall be composed of the following:

Section 4. Functions. The CPES-Implementing Unit shall perform the following functions:

- 4.1. Conduct information dissemination on CPES implementation to the concerned units/departments within the Provincial Government and to other interested users;
- 4.2. Coordinate the conduct of CPES for infrastructure projects with the concerned offices of the PG-DDN contractors and assigned accredited CPES evaluators;
- 4.3. Coordinate with CIAP on the submission and monitoring of CPES valuation results;
- 4.4. Document the gains and successes, lessons learned, difficulties met in relation to the implementation of CPES;
- 4.5. Submit monitoring and progress reports of CPES to the Provincial Governor, with copies furnished to offices implementing infrastructure projects.

Section 5. Effectivity. This Executive Order shall take effect immediately and shall remain in force until revoked;
