EXECUTIVE ORDER No. 27 Series of 2016

AN ORDER RECONSTITUTING THE PROVINCIAL PEACE AND ORDER COUNCIL (PPOC) OF THE PROVINCE OF DAVAO DEL NORTE

WHEREAS, Executive Order No. 309, as amended by the Executive Order Nos. 371, 320, and 379 and further amended by Executive Order No. 773 dated 05 January 2009 provides for the reorganization of Peace and Order Councils in all levels;

WHEREAS, Executive Order No. 773 amended the memberships and functions of the Council in order to address the pressing problem of insurgency and to provide the development programs and projects in remote rural and indigenous population areas affected by the communist activities;

WHEREAS, to be consistent with this amendment, Executive Order No. 013 was put into order on 12 November 2010 by then Governor Rodolfo P. del Rosario to reorganize the Provincial Peace and Order Council of Davao del Norte;

WHEREAS, with the assumption of the newly elected Governor of the Province of Davao del Norte and to allow a much wider participation and collaboration of various stakeholders in the society, there is a need to reconstitute the composition of the Provincial Peace and Order Council of the Province;

NOW, THEREFORE, I, ANTONIO RAFAEL G. DEL ROSARIO, Governor of the Province of Davao del Norte, by virtue of the powers vested in me by law, do hereby order the reconstitution of the Provincial Peace and Order Council:

Section 1. Composition of the Provincial Peace and Order Council.

Section 2. Duties and Functions. The PPOC shall have the following duties and functions:

- a) Provide a forum for a dialogue and deliberation of major issues and problems affecting peace and order, including insurgency;
- b) Recommend measures which will improve or enhance peace and order and public safety in their respective areas of responsibility, including anti-insurgency measures;
- Recommend measures to converge and orchestrate internal security operations efforts of civil authorities and agencies, military, and the police;
- d) Apply moral persuasion to and/or recommend sanctions against local chief executives who are giving material and political support to the communist rebels;
- Monitor the provision of livelihood and infrastructure development programs and projects in the remote rural and indigenous population areas adopted to isolate them from the communist revels "Agitate/Arouse, Organize and Mobilize" and ideological, political, and organization works;
- f) Perform all other functions assigned by law, the President of the NPOC.

Section 3. Secretariat. The Provincial PPOC Secretariat shall be headed by the DILG Provincial Director with the Assistant Provincial Director and two (2) Technical Officer. The Secretariat shall manage the PPOC Operations Center.

Section 4. Repealing Clause. Executive No. 17, Series of 2016 and other previous issuances, orders and memoranda inconsistent with the provisions of this Order are hereby repealed.

Section 5. Effectivity. This Order shall take effect immediately upon signing hereof.

This pertains to the legal opinion on the amendment Of Executive Order No. 17 Series of 2016, re: An Order Reconstituting the Provincial Peace and Order Council of the Province of Davao del Norte.

The establishment of the Provincial Peace and Order Council (PPOC) is in line with the authority of the Province provided under Section 16, Republic Act 7160, otherwise known as the "Local Government Code of 1991" and Executive Order 309, Series of 1987, as amended, which provided for the Reorganization of the Peace and Order Council.

This is further strengthened by the directive of the **DILG Memorandum Circular No. 2011-24**, issued on February 17, 2011, providing among others, the duties and functions of the Provincial Peace and Order Council.

There is a need to amend Executive Order No. 17, Series of 2016, in order to incorporate the additional members of the PPOC, as determined by the Provincial Office of the DILG, after it had conducted the Selection of Representative to the Local Special Bodies last July 14, 2016. The said selection process was conducted pursuant to the mandate of the **DILG Memorandum Circular No. 2013-70**, issued on July 24, 2013, re: Selection of Representatives to the Local Special Bodies.

With the foregoing discussion, the undersigned finds that the intended amendment is in line with the mandate of the law.
