TOMAS, THIS PROVINCE, "APPROVING AND ADOPTING THE **PROGRAMS** AND **PROJECTS PRIORITIZED** UNDER THE CY 2017 MODIFIED ANNUAL GENDER AND DEVELOPMENT (GAD) PLAN \mathbf{OF} MUNICIPALITY OF STO. TOMAS, DAVAO DEL NORTE IN THE AMOUNT OF SIXTEEN MILLION FOUR HUNDRED ELEVEN THOUSAND FOUR HUNDRED FIFTY-SEVEN PESOS AND 38/100 (P16,411,457.38) UNDER 5% GAD OF THE CY 2017 ANNUAL GENERAL FUND BUDGET OF STO. Tomas";
