

TOMAS, THIS PROVINCE, "APPROVING AND **ADOPTING PROGRAMS** THE AND **PROJECTS** PRIORITIZED UNDER THE 2017 LOCAL COUNCIL FOR PROTECTION OF CHILDREN (LCPC) PLAN OF THE MUNICIPALITY OF STO. TOMAS, DAVAO DEL NORTE WITH ALLOCATIONS IN THE FY 2017 ANNUAL GENERAL FUND BUDGET IN AMOUNT OF TWO **MILLION** HUNDRED TWENTY-SEVEN THOUSAND SIX HUNDRED THIRTY PESOS AND (P2,227,630.92)"
