

TOMAS, THIS PROVINCE, "APPROVING ADOPTING **PROGRAMS** THE PROJECTS PRIORITIZED IN THE CY 2017 RISK REDUCTION DISASTER LOCAL MANAGEMENT PLAN (LDRRMP) \mathbf{OF} MUNICIPALITY OF STO. TOMAS, DAVAO DEL NORTE WITH ALLOCATIONS IN THE CY 2017 ANNUAL GENERAL FUND BUDGET IN THE AMOUNT OF SIXTEEN MILLION FOUR **THOUSAND** FOUR ELEVEN HUNDRED HUNDRED FIFTY-SEVEN PESOS AND 38/100 ITS **EFFECTIVE** (P16,411,457.38) **FOR** IMPLEMENTATION"
