CONFIRMING RESOLUTION NO. 197, SERIES OF 2016 OF THE SANGGUNIANG BAYAN OF STO. TOMAS, THIS PROVINCE, "APPROVING AND ADOPTING THE PROGRAMS AND PROJECTS PRIORITIZED IN THE CY 2017 LOCAL DISASTER RISK REDUCTION MANAGEMENT PLAN (LDRRMP) OF THE MUNICIPALITY OF STO. TOMAS, DAVAO DEL NORTE WITH ALLOCATIONS IN THE CY 2017 ANNUAL GENERAL FUND BUDGET IN THE AMOUNT OF SIXTEEN MILLION FOUR HUNDRED ELEVEN THOUSAND FOUR HUNDRED FIFTY-SEVEN PESOS AND 38/100 (P16,411,457.38) FOR ITS EFFECTIVE IMPLEMENTATION"

WHEREAS, said measure was referred to the Committee on Human Settlements, Planning and Development and the Committee on Peace and Order/Public Safety for review and recommendation;

WHEREAS, the Committees thoroughly discussed and deliberated on the merits of the said measure and per Committee Report No. 02 dated January 11, 2017 finally recommended to confirm the same for being in order and within the bounds of law.

WHEREFORE, BE IT RESOLVED, by the Sangguniang Panlalawigan in Session Assembled, to confirm, as it is hereby confirmed, Resolution No. 197, Series of 2016 of the Sangguniang Bayan of Sto. Tomas, this Province, "Approving and adopting the programs and projects prioritized in the CY 2017 Local Disaster Risk Reduction Management Plan (LDRRMP) of the Municipality of Sto. Tomas, Davao del Norte with allocations in the CY 2017 Annual General Fund Budget in the amount of Sixteen Million Four Hundred Eleven Thousand Four Hundred Fifty-Seven Pesos and 38/100 (P16,411,457.38) for its effective implementation";
