## RESOLUTION NO. 039

**DECLARING OPERATIVE APPROPRIATION ORDINANCE NO. 2016-03, EMBODYING CY 2016 GENERAL FUND SUPPLEMENTAL BUDGET NO.02 OF THE SANGGUNIANG BAYAN OF NEW CORELLA, THIS PROVINCE, EFFECTIVE UPON THE DATE OF ITS APPROVAL SUBJECT TO THE POSTING REQUIREMENT UNDER SECTION 59 OF RA 7160 AND THE REMINDER HERETO STATED**

**WHEREAS**, a letter dated October 7, 2016 of Ms. Marina M. Bacalla, MGDH-Secretary to the Sanggunian, duly received by the Office of the Secretary to the Sangguniang Panlalawigan on October 7, 2016, transmitted to this August Body, Appropriation Ordinance No. 2016-03, embodying CY 2016 General Fund Supplemental Budget No. 02 of the Sangguniang Bayan of New Corella, this Province in the amount of Six Million Five Hundred Fifty Eight Thousand Eight Hundred Fifty Nine Pesos and Forty Centavos (Php6,558,859.40), was presented for appropriate action;

**WHEREAS**, pursuant to Section 316 of the Local Government Code of 1991, said budget was evaluated by the Local Finance Committee in

coordination with the Provincial Budget Office and the same was found to have complied with the provisions of the code. However, disbursement of appropriation for Productivity Enhancement Incentive (PEI) under various offices in the amount of Twenty Five Thousand Pesos (P25,000.00) shall be subject to the guidelines to be issued by the competent authority;

**WHEREAS**, pursuant to Section 327 of the Local Government Code of 1991, the Committee on Finance, Budget and Appropriations convened and thoroughly reviewed the said budget and per Committee Report No.021 dated January 11, 2016, recommended that the same be declared operative subject to the condition that the disbursement of appropriation for Productivity Enhancement Incentive-PEI under various offices in the amount of P25, 000.00 shall be subject to the guidelines to be issued by the competent authority;

**WHEREAS**, the LGU is hereby reminded to adhere with Joint Memorandum Circular No. 2011-1 dated April 13, 2011 of the Department of the Interior and Local Government (DILG) and the Department of Budget and Management (DBM) in the implementation of programs/projects/activities funded under 20% Development Fund. Likewise, the allocation and utilization of Local Disaster Risk Reduction and Management Fund (LDRRMF) should be in accordance with NDRRMC-DBM-DILG-Joint Memorandum Circular No. 2013-1 dated March 25, 2013.

**WHEREAS**, it is understood that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

**WHEREFORE, BE IT RESOLVED**, by the Sangguniang Panlalawigan in Session Assembled, to declare operative, as it is hereby declared operative Appropriation Ordinance No. 2016-03, embodying CY 2016 General Fund Supplemental Budget No.02 of the Sangguniang Bayan of New Corella, this Province, effective upon the date of its approval subject to the posting requirement under Section 59 of RA 7160 and the reminder hereto stated;


**RESOLVED, FURTHER**, that compliance with existing rules, laws and regulations shall be the responsibility of the Local Chief Executive;
