RESOLUTION NO. 042

CONFIRMING CITY ORDINANCE NO. 45-16 OF THE SANGGUNIANG PANLUNGSOD OF PANABO, THIS PROVINCE, AMENDING PARAGRAPHS (D) AND (E) OF SECTION 155 AND ADDING SECTION 156-D UNDER ARTICLE 18 OF ORDINANCE NO.02-13, OTHERWISE KNOWN AS "THE CODE OF ADMINISTRATIVE ORDINANCES OF 2012" OF PANABO CITY"

WHEREAS, a letter dated December 19, 2016 of Ms. Lorlyn M. Verallo, OIC-Secretary to the Sanggunian, duly received by the Office of the Secretary to the Sangguniang Panlalawigan on January 3, 2017, transmitted to this August Body, for legislative action, City Ordinance No. 45-16 of the Sangguniang Panlungsod of Panabo, this Province, was presented for appropriate action;

WHEREAS, said measure was referred to the Committee on Good Government, Public Ethics and Accountabilities and the Committee on Laws, Resolutions, Ordinances and Justice for study and recommendation;

WHEREAS, the Committees thoroughly discussed and deliberated on the merits of the said measure and per Joint Committee Report

WHEREFORE, BE IT RESOLVED, by the Sangguniang Panlalawigan in Session Assembled, to confirm, as it is hereby confirmed City Ordinance No. 45-16 of the Sangguniang Panlungsod of Panabo, this Province, amending Paragraphs (d) and (e) of Section 155 and adding Section 156-D under Article 18 of Ordinance No. 02-13, otherwise known as "The Code of Administrative Ordinances of 2012" of Panabo City;
