RESOLUTION NO. 083

DECLARING THE ENTIRE PROVINCE OF DAVAO DEL NORTE UNDER THE STATE OF CALAMITY

WHEREAS. dated a letter January 24, Honorable Antonio Rafael G. Del Rosario, (Governor) Chairman of the Provincial Disaster Risk Reduction and Management Council, this Province, duly received by the Office of the Secretary to the Sangguniang Panlalawigan on January 24, 2017, endorsed to this August Body, PDRRMC Resolution No. 003, series of 2017 recommending for the immediate passage of a resolution declaring the entire province under the state of calamity with the request that a Special Session be convened for the purpose, was presented for appropriate action;

WHEREAS, Section 15 and 16 of RA 10121 or Philippine Disaster Risk Reduction and Management Act of 2010, states that the Provincial Disaster Risk Reduction and Management Council (PDRRMC) shall recommend to the Sangguniang Panlalawigan of Davao del Norte the declaration of a State of Calamity in case two (2) or more component local government units are affected based on the result of the damage assessment and needs analysis;

WHEREAS, due to the adverse effects of heavy rains and floods that caused destruction and damages to agriculture and livelihood, the three (3) Local Government Units (LGUs) of Davao del Norte immediately passed (as of January 24, 2017) the following resolutions through the recommendation of its respective Local Disaster Risk Reduction and Management Councils:


- 1. Resolution No. 288, s-2017, dated January 24, 2017 of the Sangguniang Panlungsod of Tagum, this Province, declaring the City of Tagum under the State of Calamity due to flash floods brought by Low Pressure Area (LPA);
- 2. Resolution No. 2017-003, dated January 19, 2017 of the Sangguniang Bayan of Asuncion, this Province, declaring Municipality of Asuncion, Davao del Norte under the State of Calamity;
- 3. Resolution No. 52-s-2017, dated January 23, 2017 of the Sangguniang Bayan of Carmen, this Province, declaring the Municipality of Carmen, Davao del Norte under the State of Calamity

WHEREAS, per consolidated report made by the Rapid Disaster Analysis and Needs Assessment (RDANA) Team, there were eight (8) component LGUs that were affected in which 60,296 families were either flooded or displaced and Twenty Three Million Six Hundred Forty Eight Thousand Sixty Two Pesos and 66/100 (P23,648,062.66) total cost of damages to agriculture and livelihood due to the occurrence of tail-end cold front that intensified the torrential rain in the entire Province;

WHEREAS, considering the urgent need to facilitate the immediate assistance and needed financial aid as well as the subsequent rehabilitation of the eight (8) Local Government Units of the Province in terms of infrastructure, agriculture, some economic/social provisions, among others, the August Body agreed to immediately pass a resolution declaring the entire Province of Davao del Norte under the State of Calamity.

WHEREFORE, BE IT RESOLVED, by the Sangguniang Panlalawigan in Session Assembled to declare as it is hereby declared the entire Province of Davao del Norte under the State of Calamity;

RESOLVED FURTHER, that copy of this resolution be forwarded to Honorable Antonio Rafael G. del Rosario, Governor, this Province, for appropriate action; let copies of the same be furnished the Provincial Disaster Risk Reduction and Management Council through Mr. Samson J. Sanchez, MPA, CSEE, (Provincial Administrator) Action Officer, PDRRMD, Mr. Alex C. Roldan, CESO V, Provincial Director, Department of the Interior and Local Government, Mr. Alfredo G. Largo, State Auditor III, OIC-Audit Team Leader, Commission on Audit, Ms. Arlene M. Semblante, RSW, Provincial Social Welfare and Development Officer, Ms. Serlinda C. Atake, CPA, MBA, Provincial Accountant, Ms. Regina C. Ricafort, CPA, Provincial Treasurer,
