**RESOLUTION NO. 086**

**CONFIRMING CITY ORDINANCE NO. 46-16 OF THE SANGGUNIANG PANLUNGSOD OF PANABO, THIS PROVINCE, "AMENDING THE ORGANIZATIONAL STRUCTURE, STAFFING CLASSIFICATION AND ACTION SUMMARY (OSSCAS) AS EMBODIED IN THE CODE OF ADMINISTRATIVE ORDINANCE OF 2012, AS AMENDED"**

**WHEREAS**, a letter dated December 19, 2016 of Ms. Lorlyn M. Verallo, OIC-Secretary to the Sanggunian, duly received by the Office of the Secretary to the Sangguniang Panlalawigan on January 3, 2017, transmitted to this August Body, City Ordinance No. 46-16 of the Sangguniang Panlungsod of Panabo, this Province, was presented for appropriate action;

**WHEREAS**, said measure was referred to the Committee on Good Government, Public Ethics and Accountabilities and the Committee on Laws, Resolutions, Ordinances and Justice for study and recommendation;

**WHEREAS**, the Committees thoroughly discussed and deliberated on the merits of the said measure and per Joint Committee Report No. 02 dated January 25, 2017, recommended to confirm the same for

being in order and within the bounds of law, provided that the Republic Act No. 6656, An Act to Protect the Security of Tenure of Civil Service Officers and Employees in the Implementation of Government Organization be observed.

**WHEREFORE, BE IT RESOLVED**, by the Sangguniang Panlalawigan in Session Assembled, to confirm, as it is hereby confirmed City Ordinance No.46-16 of the Sangguniang Panlungsod of Panabo, this Province, "Amending the Organizational Structure, Staffing Classification and Action Summary (OSSCAS) as embodied in the Code of Administrative Ordinance of 2012, as amended";


