CONFIRMING CITY ORDINANCE NO. 46-16 OF THE SANGGUNIANG PANLUNGSOD OF PANABO, THIS PROVINCE, "AMENDING THE ORGANIZATIONAL STRUCTURE, STAFFING CLASSIFICATION AND ACTION SUMMARY (OSSCAS) AS EMBODIED IN THE CODE OF ADMINISTRATIVE ORDINANCE OF 2012, AS AMENDED"
