DEL ROSARIO, GOVERNOR, THIS PROVINCE TO SIGN THE MEMORANDUM OF UNDERSTANDING, ENTERED INTO BY AND BETWEEN THE CITY GOVERNMENT OF TAGUM, REPRESENTED BY ITS CITY MAYOR, HON. ALLAN L. RELLON, DPA, PH.D. HEREIN REFERRED TO AS THE LGU-CITY OF TAGUM AND THE PROVINCIAL GOVERNMENT OF DAVAO DEL NORTE, REPRESENTED BY THE HONORABLE GOVERNOR, HEREIN REFERRED TO AS THE LGU-PROVINCE OF DAVAO DEL NORTE, RELATIVE TO THE GRANT OF EASEMENT FOR **ESTABLISHMENT**  $\mathbf{OF}$ THE PROVINCIAL MANGROVE REHABILITATION, ENRICHMENT AND CONSERVATION AREA

WHEREAS, a letter dated 08 December 2016 of Mr. Sofonias P. Gabonada Jr., Provincial Information Officer, OIC-Office of the Governor, this Province, duly received by the Office of the Secretary to the Sangguniang Panlalawigan on January 3, 2017, endorsed to this August Body the Memorandum of Understanding to be entered into by and between the City Government of Tagum and the Provincial Government of Davao del Norte, was presented for appropriate action;

**WHEREAS,** the Committees thoroughly discussed and deliberated on the merits of the said measure and per Joint Committee Report No. 01 dated January 18, 2017, finally recommended to confirm the same for being in order and within the bounds of law.

WHEREFORE, BE IT RESOLVED, by the Sangguniang Panlalawigan in Session Assembled, to authorize, as it is hereby authorized, Hon. Antonio Rafael G. del Rosario, Governor, this Province, to sign the Memorandum of Understanding, entered into by and between the City Government of Tagum, represented by its City Mayor, Hon. Allan L. Rellon, DPA, Ph.D, herein referred to as the LGU-City of Tagum and the Provincial Government of Davao del Norte, represented by the Honorable Governor, herein referred to as the LGU-Province of Davao del Norte, relative to the Grant of Easement for the Establishment of the Provincial Mangrove Rehabilitation, Enrichment and Conservation Area;
