DEL ROSARIO, GOVERNOR, PROVINCE TO SIGN THE CONTRACT OF SERVICE, ENTERED INTO BY AND BETWEEN THE PROVINCIAL GOVERNMENT OF DAVAO DEL NORTE, HEREIN REPRESENTED BY THE GOVERNOR, HEREINAFTER CALLED AS THE PARTY OF THE FIRST PART AND THE UNIVERSITY OF MINDANAO BROADCASTING NETWORK (UMBN-DXDN), HEREIN REPRESENTED OIC-STATION MANAGER, MR. ROY T. GEONZON, HEREINAFTER CALLED AS THE PARTY THE SECOND PART, RELATIVE TO THE RENEWAL OF SERVICES FOR A REMOTE LIVE COVERAGE OF THE WEEKLY SESSIONS OF THE SANGGUNIANG PANLALAWIGAN FROM JANUARY 1 **TO DECEMBER 31, 2017**

WHEREAS, a letter dated 13 December 2016 of Hon. Alan R. Dujali, MPA (Vice Governor), Acting Governor, this Province, duly received by the Office of the Secretary to the Sangguniang Panlalawigan on January 3, 2017, endorsed to this August Body, the Contract of Service to be entered into by and between the Provincial Government of

Davao del Norte and the University of Mindanao Broadcasting Network (UMBN-DXDN), was presented for appropriate action;

WHEREAS, said measure was referred to the Committee on Laws, Resolutions, Ordinances and Justice and the Committee on Information and Media Affairs for study and recommendation;

WHEREAS, the Committees thoroughly discussed and deliberated on the merits of the said measure and per Joint Committee Report No. 01 dated January 18, 2017, finally recommended to confirm the same for being in order and within the bounds of law.

WHEREFORE, BE IT RESOLVED, by the Sangguniang Panlalawigan in Session Assembled, to authorize, as it is hereby authorized, Hon. Antonio Rafael G. del Rosario, Governor, this Province, to sign the Contract of Service entered into by and between the Provincial Government of Davao del Norte, herein represented by the Governor, hereinafter called as the Party of the First Part and the University of Mindanao Broadcasting Network (UMBN-DXDN), herein represented by its OIC-Station Manager, Mr. Roy T. Geonzon, hereinafter called as the party of the second part, relative to the renewal of services for a remote live coverage of the weekly sessions of the Sangguniang Panlalawigan from January 1 to December 31, 2017;

RESOLVED, FURTHER, that copy of this resolution be forwarded to Honorable Antonio Rafael G. Del Rosario, Governor, this Province, for appropriate action; let copies of the same be furnished Mr. Roy T. Geonzon, OIC-Station Manager, UMBN-DXDN, Tagum City and Atty. Jennifer B.
