### **RESOLUTION NO. 090**

**AUTHORIZING HONORABLE ANTONIO RAFAEL G. DEL ROSARIO, GOVERNOR, THIS PROVINCE TO SIGN THE MEMORANDUM OF UNDERSTANDING ENTERED INTO BY AND BETWEEN THE ST. MARY'S COLLEGE OF TAGUM, INC., KILOMETER 55 NATIONAL HIGHWAY, TAGUM CITY, REPRESENTED BY S. MARIA LORINA A. JUMAWAN, RVM, SCHOOL PRESIDENT, AS FIRST PARTY AND THE PROVINCIAL GOVERNMENT OF DAVAO DEL NORTE, REPRESENTED BY THE HONORABLE GOVERNOR AS SECOND PARTY, RELATIVE TO THE IMPLEMENTATION OF DISASTER PREPAREDNESS TRAINING PROGRAMS**

**WHEREAS**, a letter dated 23 November 2016 of Hon. Antonio Rafael G. del Rosario, Governor, this Province, duly received by the Office of the Secretary to the Sangguniang Panlalawigan on November 24, 2016, endorsed to this August Body the Memorandum of Understanding to be entered into by and between the St. Mary's College of Tagum, Inc., and the Provincial Government of Davao del Norte, was presented for appropriate action;

**WHEREAS**, said measure was referred to the Committee on Laws, Resolutions, Ordinances and Justice, the Committee on Peace and Order/Public Safety and the Committee on Education and Culture for study and recommendation;

**WHEREAS**, the Committees thoroughly discussed and deliberated on the merits of the said measure and per Multiple Committee Report No. 01 dated January 18, 2017, finally recommended to confirm the same for being in order, however the terms and amendment of the said memorandum shall take effect upon approval of the authority of the Governor to sign the same.

**WHEREFORE, BE IT RESOLVED**, by the Sangguniang Panlalawigan in Session Assembled, to authorize, as it is hereby authorized, Hon. Antonio Rafael G. del Rosario, Governor, this Province, to sign the Memorandum of Understanding entered into by and between the St. Mary's College of Tagum, Inc., Kilometer 55 National Highway, Tagum City, represented by S. Maria Lorina A. Jumawan, RVM, School President, as First Party and the Provincial Government of Davao del Norte, represented by the Honorable Governor as Second Party, relative to the implementation of disaster preparedness training programs;


**RESOLVED, FURTHER**, that copy of this resolution be forwarded to Honorable Antonio Rafael G. Del Rosario, Governor, this Province, for appropriate action; let copies of the same be furnished S.
