INVITATION TO BID FOR INFRASTRUCTURE PROJECTS

The Provincial Government of Davao Del Norte, through DA 2018, Stimulus 2018, DA, 20% DF and SB #1 2019 intends to apply the sum of Five Million Two Hundred Forty Seven Thousand Six Hundred Thirty Nine and 67/100 Pesos (Php 5,247,639.67) and being the Approved Budget for the Contract (ABC) to payment under the contract with Project ID/PR Nos. 19083231, 19083312, 19093383, 19093434 and 19093715. Bids received in excess of the ABC shall be automatically rejected at bid opening.

- 3 The prospective bidder must have completed a Single Largest Completed Contract(SLCC) that is similar to the contract to be bid, and whose value, adjusted to current prices using the PSA consumer price indices, must be at least fifty percent (50%) of the ABC to be bid: Provided, however, That contractors under Small A and Small B categories without similar experience on the contract to be bid may be allowed to bid if the cost of such contract is not more than the Allowable Range of Contract Cost (ARCC) of their registration based on the guidelines as prescribed by the PCAB. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

 Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines

- A complete set of Bidding Documents may be acquired by interested Bidders on November 27, 2019 to December 16, 2019 from the address below and upon payment of a nonrefundable fee for the Bidding Documents pursuant to Provincial Tax Ordinance No. 2017-001.
 - It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the fee for the Bidding Documents not later that the submission of their bids
