- The Provincial Government of Davao del Norte, through LCCAP 5% Calamity Fund CY 2020 intends to apply the sum of Five Hundred Thousand Pesos (P500,000.00) being the Approved Budget for the Contract to payment under the contract for the One Package E-LCCAP re: Greenhouse Gas Inventory for 3 selected pilot LGUs and Barangay Level. Bids received in excess of the ABC shall be automatically rejected at the opening of financial proposals.

- The Provincial Government of Davao del Norte now calls for the submission of eligibility documents One Package E-LCCAP re: Greenhouse Gas Inventory for 3 Selected Pilot LGUs and Barangay Level. Eligibility documents of interested consultants must be duly received by the BAC Secretariat on or before **February 24, 2020** at Provincial General Services Office (PGSO) Conference Room, 2F PGSO Bldg., Government Center, Mankilam, Tagum City. Applications for eligibility will be evaluated based on a non-discretionary "pass/fail" criterion.
- Interested bidders may obtain further information from The Provincial Government of Davao del Norte and inspect the Bidding Documents at the address given below from 8:00 a.m. to 5:00 p.m., from Monday to Friday upon payment of the bidding rate in the amount of P500.00.
- A complete set of Bidding Documents may be acquired by interested Bidders on **January 31, 2020 to February 23, 2020**, from the address below and upon payment of a nonrefundable fee for the Bidding Documents pursuant to Provincial Tax Ordinance No. 2017-001.
It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.
- The BAC shall draw up the short list of consultants from those who have submitted Expression of Interest, including the eligibility documents, and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act", and its Implementing Rules and Regulations (IRR). The criteria and rating system for short listing are as follows:

* Eligible Consultants should pass the hurdle rate of 70% to be considered shortlisted


- Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the IRR of RA 9184.
Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
- The Provincial Government of Davao del Norte shall evaluate bids using the Quality-Cost Based Evaluation (QCBE) procedure at a weight ratio of 80% for the Technical Proposal and 20% for the Financial Proposal. The criteria and rating system for the evaluation of proposals shall be provided in the Instructions to Bidders (ITB).
- The contract shall be completed within five (5) months upon receipt of Notice to Proceed.
- The Provincial Government of Davao del Norte reserves the right to accept or reject any bid and all bids, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
