



INVITATION TO BID FOR INFRASTRUCTURE PROJECTS

- 1 The Provincial Government of Davao del Norte, through 20% Development Fund CY 2020 and Trust Fund (NHA), intends to apply the sum of Forty Two Million Four Hundred Twenty Five Thousand Seventy Six and 04/100 Pesos (Php 42,425,076.04) and being the Approved Budget for the Contract (ABC) to payment under the contract with Project ID/PR No. 20074453, 20053370 and 20063653. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The prospective bidder must have completed a Single Largest Completed Contract(SLCC) that is similar to the contract to be bid, and whose value, adjusted to current prices using the PSA consumer price indices, must be at least fifty percent (50%) of the ABC to be bid: Provided, however, That contractors under Small A and Small B categories without similar experience on the contract to be bid may be allowed to bid if the cost of such contract is not more than the Allowable Range of Contract Cost (ARCC) of their registration based on the guidelines as prescribed by the PCAB. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

- 8 **Bids must be delivered to the address below on or before September 15, 2020 at 10:00 in the morning at Procurement Planning and Purchasing Section, 2nd Floor PGSO Building, Government Center, Mankilam, Tagum City.** All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16 or Bid Securing Declaration pursuant to GPPB Resolution No. 03-2012.
Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
