WITNESSETH THAT:

WHEREAS, the Procuring Entity is a local government unit mandated to provide infrastructure facilities to service the needs of the residents of the province and which funded out of provincial funds including, but not limited to, provincial roads and bridges; intermunicipal waterworks, drainage and other similar facilities;

WHEREAS, pursuant to Section 53.12 of IRR of RA 9184 and GPPB Resolution No. 03-2013 dated January 21, 2013, it recognize the Community Participation and authorize the Procuring Entity to grant the rural community-based contractors in the procurement of goods and services and simple infrastructure projects through negotiated agreement particularly the rural road maintenance in some areas of the Province of Davao del Norte;

WHEREAS, the Procuring Entity under General Fund CY 2020, intends to apply the sum of SIXTY-ONE THOUSAND TWO HUNDRED FIFTEEN PESOS AND NINETY-NINE CENTAVOS (PHP 61,215.99) being the Approved Budget for the Contract (ABC) for the Contract - Community Based Road Maintenance Contracting (CBRMC) and the bidding was conducted for the purpose of maintaining various Provincial Roads and Bridges - DATU BALONG-PRK. MAMALIAN, governed by Republic Act 9184 otherwise known as "The Government Procurement Reform Act";

WHEREAS, upon the opening of negotiated procurement and after proper evaluation of the criteria and standards set forth by law, the Bids and Awards Committee (BAC) through BAC **Resolution No. 197, series of 2020,** resolved to declare the Contractor as the Single Calculated and Responsive Bidder to undertake the afore-cited Project;

WHEREAS, the Contractor is willing to undertake and implement the project in the manner provided under this contract, existing laws and/or upon the request by the Procuring Entity.

NOW THEREFORE, for and in consideration of the foregoing premises, the parties hereto agreed, as by these presents, do hereby agree to be bound by the following terms and conditions, to wit:

I-CONTRACT

This agreement is an infrastructure project between the **PROVINCIAL GOVERNMENT** OF DAVAO DEL NORTE and DATU BALONG FARMERS ASSOCIATION, INC., with approved project pursuant to PR No. 2001-0306, hereinafter called the "Community-Based Road Maintenance Contract".

The project consists of Contract - Community Based Road Maintenance Contracting (CBRMC) for the maintenance of various Provincial Roads and Bridges + DATU BALONG-PRK. MAMALIAN.

Progress billing will be made every quarter.

II-DURATION

The intended project should be done within four (4) quarters from the time the Notice to Proceed was issued by the Procuring Entity and received/acknowledged by the Contractor.

III-CONTRACT PRICE

The Provincial Government of Davao del Norte has an Approved Budget of the Contract (ABC) of SIXTY-ONE THOUSAND TWO HUNDRED FIFTEEN PESOS AND NINETY-NINE CENTAVOS (PHP 61,215.99) The Contractor submitted a bid quotation of SIXTY-ONE THOUSAND PESOS (PHP 61,000.00) based on the Purchase Order No. 2020031389.

The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by this Contract.
