KNOW ALL MEN BY THESE PRESENTS:

This Agreement is made and entered into this ____ day of EB 2 3 2021 __, 2021 at Tagum City, Davao del Norte, Philippines, between:

PROVINCIAL GOVERNMENT OF DAVAO DEL NORTE, a local government unit duly organized and existing under the laws of the Republic of the Philippines with office address at Capitol Bldg., Government Center, Barangay Mankilam, Tagum City, Davao del Norte, represented by the Head of the Procuring Entity, Honorable Governor **EDWIN I. JUBAHIB**, hereinafter referred to as the **PROCURING ENTITY**;

-AND-

RELY CONSTRUCTION & SUPPLY, a registered construction firm under the Department of Trade and Industry with Certificate No. 03990987, dated 10-Mar-2016, with business address at Km. 7, Tigatto Road, Buhangin, Davao City, Davao del Sur, duly represented by its Owner/Sole Proprietor, **RENATO R. CASTANEDA**, hereinafter referred to as the **CONTRACTOR**.

WITNESSETH THAT:

WHEREAS, the Procuring Entity is a local government unit mandated to provide infrastructure facilities to service the needs of the residents of the province and which funded out of provincial funds including, but not limited to, provincial roads and bridges; intermunicipal waterworks, drainage and other similar facilities;

WHEREAS, the Procuring Entity through DA LIVESTOCK BANNER PROGRAM, intends to apply the sum of ONE MILLION FIFTY-SEVEN THOUSAND SIX HUNDRED THIRTY-THREE PESOS AND SEVENTY-TWO CENTAVOS (PHP 1,057,633.72) being the Approved Budget for the Contract (ABC) for the 1 Lot Contract Package: Equipment, Labor and Materials for the Establishment Of Livestock And Poultry Multiplier Farm at Datu Abdul, Panabo City, Davao del Norte by virtue of the Purchase Request No. 2009-5721, the bidding was conducted for the purpose through Infrastructure Project Agreement governed by Republic Act 9184 otherwise known as "The Government Procurement Reform Act";

WHEREAS, upon the opening of competitive bidding and after proper evaluation of the criteria and standards set forth by law, the Bids and Awards Committee (BAC) through BAC Resolution No. 10, series of 2021, resolved to declare the Contractor as the Lowest Calculated and Responsive Bidder to undertake the afore-cited Infrastructure Project;

WHEREAS, the Contractor has been in the business of conducting construction, rehabilitation, improvements of buildings, bridges and other infrastructure projects in different areas of the country particularly in Mindanao area including rural construction facilities;

WHEREAS, the Contractor is willing to undertake and implement the project in the manner provided under this contract, existing laws and/or upon the request by the Procuring Entity.

NOW THEREFORE, for and in consideration of the foregoing premises, the parties hereto agreed, as by these presents, do hereby agree to be bound by the following terms and conditions, to wit:

I-CONTRACT

This agreement is an infrastructure project between the **PROVINCIAL GOVERNMENT OF DAVAO DEL NORTE** and **RELY CONSTRUCTION & SUPPLY** with approved project pursuant to **Purchase Request No. 2009-5721**, hereinafter called the "Infrastructure Project".

The project consists of 1 Lot Contract Package: Equipment, Labor and Materials for the Establishment of Livestock and Poultry Multiplier Farm at Datu Abdul, Panabo City, Davao del Norte.

Payment shall be made **through progress billing**. However, there shall be no release of final payment unless and until the project has been completed, inspected, accepted and duly certified by the Procuring Entity to its final satisfaction.

II-DURATION

The intended work duration is **ONE HUNDRED (100) CALENDAR DAYS**, from the time the Notice to Proceed was issued by the Procuring Entity and received/acknowledged by the Contractor.

III-CONTRACT PRICE

The Provincial Government of Davao del Norte has an Approved Budget of the Contract (ABC) of ONE MILLION FIFTY-SEVEN THOUSAND SIX HUNDRED THIRTY-THREE PESOS AND SEVENTY-TWO CENTAVOS (PHP 1,057,633.72). The Contractor submitted a bid quotation of ONE MILLION THIRTY-ONE THOUSAND SEVEN HUNDRED FIFTEEN PESOS AND FOUR CENTAVOS (PHP 1,031,715.04).

IV-GENERAL TERMS AND CONDITIONS
