KNOW ALL MEN BY THESE PRESENTS:

This Agreement is made and entered into this ____ day of _JUL 1 4 2022 , 2022 at Tagum City, Davao del Norte, Philippines, between:

PROVINCIAL GOVERNMENT OF DAVAO DEL NORTE, a local government unit duly organized and existing under the laws of the Republic of the Philippines with office address at Capitol Bldg., Government Center, Barangay Mankilam, Tagum City, Davao del Norte, represented by the Head of the Procuring Entity, Honorable Governor **EDWIN I. JUBAHIB**, hereinafter referred to as the **PROCURING ENTITY**;

-AND-

ATR CONSTRUCTION, a registered construction firm under the Department of Trade and Industry with Certificate No. 03237679, dated 11-October-2021, with business address at Road to Lavista Monte Village, Balusong Ext., Brgy. Matina Crossing, Davao City, Davao del Sur, duly represented by its Proprietor, MARGARITA V. REMOLLO, hereinafter referred to as the CONTRACTOR.

WITNESSETH THAT:

WHEREAS, the Procuring Entity is a local government unit mandated to provide infrastructure facilities to service the needs of the residents of the province and which funded out of provincial funds including, but not limited to, provincial roads and bridges; inter-municipal waterworks, drainage and other similar facilities;

WHEREAS, the Procuring Entity through SUPPLEMENTAL BUDGET NO. 3 CY 2021, intends to apply the sum of ONE MILLION THREE HUNDRED NINETY-ONE THOUSAND THREE HUNDRED SIXTY-NINE PESOS AND FIFTY-NINE CENTAVOS (PHP 1,391,369.59) being the Approved Budget for the Contract (ABC) for the 1 LOT CONTRACT PACKAGE: EQUIPMENT, LABOR AND MATERIALS FOR THE IMPROVEMENT OF WATER SYSTEM AT BRGY. DALISAY, PANABO CITY, DAVAO DEL NORTE by virtue of the Purchase Request No. 2022010666 the bidding was conducted for the purpose through Infrastructure Project Agreement governed by Republic Act 9184 otherwise known as "The Government Procurement Reform Act";

WHEREAS, upon the opening of competitive bidding and after proper evaluation of the criteria and standards set forth by law, the Bids and Awards Committee (BAC) through BAC Resolution No. 190, series of 2022, resolved to declare the Contractor as the Single Calculated and Responsive Bidder to undertake the afore-fited Infrastructure Project;

WHEREAS, the Contractor has been in the business of conducting construction, rehabilitation, improvements of buildings, bridges and other infrastructure projects in different areas of the country particularly in Mindanao area including rural construction facilities;

WHEREAS, the Contractor is willing to undertake and implement the project in the manner provided under this contract, existing laws and/or upon the request by the Procuring Entity.

NOW THEREFORE, for and in consideration of the foregoing premises, the parties hereto agreed, as by these presents, do hereby agree to be bound by the following terms and conditions, to wit:

I-CONTRACT

This agreement is an infrastructure project between the **PROVINCIAL GOVERNMENT OF DAVAO DEL NORTE** and **ATR CONSTRUCTION** with approved project pursuant to **Purchase Request No. 2022010666** hereinafter called the *Infrastructure Project".

The project consists of the 1 LOT CONTRACT PACKAGE: EQUIPMENT, LABOR AND MATERIALS FOR THE IMPROVEMENT OF WATER SYSTEM AT BRGY. DALISAY, PANABO CITY, DAVAO DEL NORTE.

Payment shall be made **through progress billing**. However, advance payment may be allowed upon formal request and approval of the other party in an amount not exceeding fifteen percent (15%) of the total contract price. But no release of final payment can be made unless and until the project has been completed, inspected and accepted by the Procuring Entity to its full satisfaction.

II-DURATION

The intended work duration is **SIXTY (60) CALENDAR DAYS**, from the time the Notice to Proceed was issued by the Procuring Entity and received/acknowledged by the Contractor.

III-CONTRACT PRICE

The Provincial Government of Davao del Norte has an Approved Budget of the Contract (ABC) of ONE MILLION THREE HUNDRED NINETY-ONE THOUSAND THREE HUNDRED SIXTY-NINE PESOS AND FIFTY-NINE CENTAVOS (PHP 1,391,369.59). The Contractor submitted a bid quotation of ONE MILLION THREE HUNDRED EIGHTY-SIX THOUSAND FOUR HUNDRED TWENTY-NINE PESOS AND NINETEEN CENTAVOS (PHP 1,386,429.19)

IV-GENERAL TERMS AND CONDITIONS

- In this contract, words and expressions shall have the same meanings as are respectively assigned to them in the General and Special Conditions of the Contract. Whatever conflicts as to the provisions of the contract, the Special Conditions of the Contract shall prevail;
