This Agreement is made and entered into this _____ day of _____, 2022 at Tagum City, Davao del Norte, Philippines, between:

PROVINCIAL GOVERNMENT OF DAVAO DEL NORTE, a local government unit duly organized and existing under the laws of the Republic of the Philippines with office address at Capitol Bldg, Government Center, Barangay Mankilam, Tagum City, Davao del Norte, represented by the Head of the Procuring Entity, Honorable Governor **EDWIN I. JUBAHIB**, hereinafter referred to as the **PROCURING ENTITY**;

-and-

BRGY. MANGALCAL WOMENS HOMEBASED WORKERS ASSOCIATION, a registered workers' association under the Department of Labor and Employment with Registration Number ROXI – DNFO – WA – 07 -2016 -078 and business address at Purok 4, San Miguel, Santo Tomas, Davao del Norte duly represented by its President, **MELDRID REGILDA Q. DENOYO**, hereinafter referred to as the **CONTRACTOR**.

WITNESSETH THAT:

WHEREAS, the Procuring Entity is a local government unit mandated to provide infrastructure facilities to service the needs of the residents of the province and which funded out of provincial funds including, but not limited to, provincial roads and bridges; inter-municipal waterworks, drainage and other similar facilities;

WHEREAS, pursuant to Section 53.12 of IRR of RA 9184 and GPPB Resolution No. 03-2013 dated January 21, 2013, it recognize the Community Participation and authorize the Procuring Entity to grant the rural community-based contractors in the procurement of goods and services and simple infrastructure projects through negotiated agreement particularly the rural road maintenance in some areas of the Province of Davao del Norte;

WHEREAS, the Procuring Entity under **Repair and Maintenance- Infrastructure Assets (50213030)**, intends to apply the sum of **ONE HUNDRED THIRTY-NINE THOUSAND NINE HUNDRED SIXTY-ONE PESOS AND SEVENTY-TWO CENTAVOS (PHP 139,961.72)** being the Approved Budget for the Contract (ABC) for the Contract – Community Based Road Maintenance Contracting (CBRMC) and the bidding was conducted for the purpose of maintaining various Provincial Roads and Bridges – **11DAN073 – CEBULANO - MANGALCAL**, governed by Republic Act 9184 otherwise known as "The Government Procurement Reform Act";

WHEREAS, upon the opening of negotiated procurement and after proper evaluation of the criteria and standards set forth by law, the Bids and Awards Committee (BAC) through **BAC Resolution No. 380, series of 2022**, resolved to declare the Contractor as the **Single Calculated and Responsive Bidder** to undertake the afore-cited Project;

WHEREAS, the Contractor is willing to undertake and implement the project in the manner provided under this contract, existing laws and/or upon the request by the Procuring Entity;

NOW THEREFORE, for and in consideration of the foregoing premises, the parties hereto agreed, as by these presents, do hereby agree to be bound by the following terms and conditions, to wit:

I-CONTRACT

This agreement is an infrastructure project between the **PROVINCIAL GOVERNMENT OF DAVAO DEL NORTE** and **BRGY. MANGALCAL WOMENS HOMEBASED WORKERS ASSOCIATION** with approved project pursuant to **PR No. 2022010113**, hereinafter called the "Community-Based Road Maintenance Contract".

The project consists of Contract - Community Based Road Maintenance Contracting (CBRMC) for the maintenance of various Provincial Roads and Bridges - **11DAN073 - CEBULANO - MANGALCAL.**

Progress billing will be made within the quarter.

II-DURATION

The intended project should be done **within two (2) quarters** from the time the Notice to Proceed was issued by the Procuring Entity and received/acknowledged by the Contractor.

III-CONTRACT PRICE

The Provincial Government of Davao del Norte has an Approved Budget of the Contract (ABC) of **ONE HUNDRED THIRTY-NINE THOUSAND NINE HUNDRED SIXTY-ONE PESOS AND SEVENTY-TWO CENTAVOS (PHP 139,961.72)**. The Contractor submitted a bid quotation of **ONE HUNDRED THIRTY-NINE THOUSAND NINE HUNDRED SIXTY-ONE PESOS ONLY (PHP 139,961.00)**.

IV-GENERAL TERMS AND CONDITIONS

1. In this contract, words and expressions shall have the same meanings as are respectively assigned to them in the **Terms and Conditions** as stipulated in the Price Quotation Form (PQF)/Canvass Form.
2. The Project bidding documents (**Annex "A"**) shall be attached, deemed to form as integral part of this contract, and be read and construed substantially in the following order as stated below:
 - I. Invitation to Bid;
 - II. Purchase Request;
 - III. Program of Works;
 - IV. Price Quotation Form (PQF)/Canvass Form; and
 - V. Legal, Technical and Financial Documents.

3. Advance payment may be released in an amount not exceeding fifteen percent (15%) of the total contract price provided it is included in the contract;

4. The contractor shall submit project bills in amount of work accomplished that contains the amount due the contractor for the work performed pursuant to the work and financial plan;

5. The contractor shall submit bills in amount of work accomplished pursuant to the work and financial plan.





