WITNESSETH THAT:

WHEREAS, the Procuring Entity is a local government unit mandated to provide infrastructure facilities to service the needs of the residents of the province and which funded out of provincial funds including, but not limited to, provincial roads and bridges; inter-municipal waterworks, drainage and other similar facilities;

WHEREAS, pursuant to Section 53.12 of IRR of RA 9184 and GPPB Resolution No. 03-2013 dated January 21, 2013, it recognizes the Community Participation and authorize the Procuring Entity to grant the rural community-based contractors in the procurement of goods and services and simple infrastructure projects through negotiated agreement particularly the rural road maintenance in some areas of the Province of Davao del Norte;



WHEREAS, the Procuring Entity through 20% Development Fund CY 2023, intends to apply the sum of SIXTY-NINE THOUSAND SIX HUNDRED THIRTY-NINE PESOS AND FORTY-NINE CENTAVOS (PHP69,639.49) being the Approved Budget for the Contract (ABC) for the Contract — Community Based Road Maintenance Contracting (CBRMC) and the bidding was conducted for the purpose of maintaining the Provincial Road in - SITIO PARADISE - MAGKAKAISA — ESPERANZA (Add I), governed by Republic Act 9184 otherwise known as "The Government Procurement Reform Act";



WHEREAS, upon the opening of negotiated procurement and after proper evaluation of the criteria and standards set forth by law, the Bids and Awards Committee (BAC) through BAC Resolution No. 325, series of 2023, resolved to declare the Contractor as the Single Calculated and Responsive Bidder to undertake the afore-cited Project;

WHEREAS, the Contractor is willing to undertake and implement the project in the manner provided under this contract, existing laws and/or upon the request by the Procuring Entity.

NOW THEREFORE, for and in consideration of the foregoing premises, the parties hereto agreed, as by these presents, do hereby agree to be bound by the following terms and conditions, to wit:

I-CONTRACT

This agreement is an infrastructure project between the **PROVINCIAL GOVERNMENT OF DAVAO DEL NORTE** and **LOS AMIGOS GROUP OF WOMEN AND FARMERS ASSOCIATION (LAGWAFA)** with approved project pursuant to **PR No. 2023084729**, hereinafter called the "Community-Based Road Maintenance Contract".


