I-CONTRACT

This agreement is an infrastructure project between the **PROVINCIAL GOVERNMENT OF DAVAO DEL NORTE** and **MAHAYAHAY INTEGRATED FARMERS ASSOCIATION** with approved project pursuant to **PR No. 2023010656**, hereinafter called the "Community-Based Road Maintenance Contract".

The project consists of Contract – Community Based Road Maintenance Contracting (CBRMC) for the maintenance of Provincial Road in – **MESAOY - JCT. MAHAYAHAY.**

Progress billing will be made every quarter.

II-DURATION

The intended project should be done within three (3) quarters from the time the Notice to Proceed was issued by the Procuring Entity and received/acknowledged by the Contractor.

III-CONTRACT PRICE

The Provincial Government of Davao del Norte has an Approved Budget of the Contract (ABC) of **ONE HUNDRED THIRTY-TWO THOUSAND SEVEN HUNDRED FORTY-TWO PESOS AND TWO CENTAVOS (PHP 132,742.02).** The Contractor submitted a bid quotation of **ONE HUNDRED THIRTY-TWO THOUSAND SEVEN HUNDRED FORTY-TWO PESOS AND TWO CENTAVOS (PHP 132,742.02).**

- 3. Advance payment may be released in an amount not exceeding fifteen percent (15%) of the total contract price provided it is included in the contract;
- 4. The contractor shall submit progress billing or statement of work accomplished that contains the amount due the contractor vis-a-vis the work performed pursuant to the work and financial plan;
- 5. The procuring entity shall release payments based on the payment scheme provided in the contract and only upon validation by the end user unit that the contractor has delivered or performed the outputs specified in the work and financial plan and the same has been inspected and accepted by the community and confirmed by the
