WHEREAS, the Obligee requires a performance security in the above stated sum to secure the full and faithful

as specified in the bidding documents/terms of reference pursuant to Section 39 of the Implementing Rules
and Regulations of R.A. No. 9184 and an additional one year (1) coverage from date of completion up to final acceptance to
guarantee that the above-bounden Principal shall undertake the repair works of any damage to the infrastructure on account
of the use of materials of inferior quality discovered within the defects liability period pursuant to Section 62 of the
Implementing Rules and Regulations (IRR) of R.A. 9184.

This bond is callable on demand. The liability of the surety company shall in no case exceed the sum of FOUR HUNDRED FIFTY NINE THOUSAND NINE HUNDRED SIXTY ONLY (PhP 459,960.00) Philippine Currency. In
case of default or failure of the Principal, the Obligee shall notify the Surety by sending the notice of claim with attached
supporting documents to prove default or failure to comply by the Principal.

NOW THEREFORE, if the Principal shall well and truly perform and fulfill all the undertakings, covenants, terms, conditions,
and agreements stipulated in said contract, R.A. No. 9184 and its Implementing Rules and Regulations, then the obligation shall
be null and void; otherwise it shall remain in full force and effect.

The liability of the Surety under this bond shall remain valid until issuance by the Obligee of the certificate of final acceptance
pursuant to Section 39, IRR of R.A. No. 9184 and that the Surety does not assume responsibility for any liability incurred or created
after the expiry date. It has been agreed that the Surety is released from liability after the issuance of the certificate of final
acceptance. The Surety shall not be liable for extension of contract unless an endorsement has been issued consenting to such
extension.
