I-CONTRACT

This agreement is an infrastructure project between the **PROVINCIAL GOVERNMENT OF DAVAO DEL NORTE** and **ASSOCIATION ALTERNATIVE LIVELIHOOD OF LIBUTON INC. (AALI)**with approved project pursuant to **PR No. 2021122166**, hereinafter called the "Community-Based Road Maintenance Contract".

The project consists of Contract – Community Based Road Maintenance Contracting (CBRMC) for the maintenance of various. Provincial Roads and Bridges – **JCT. DACUDAO - MABUHAY.**

Progress billing will be made every quarter.

II-DURATION

The intended project should be done **within three (3) quarters** from the time the Notice to Proceed was issued by the Procuring Entity and received/act nowledged by the Contractor.

III-CONTRACT PRICE

The Provincial Government of Davao del Norte has an Approved Budget of the Contract (ABC) of **THIRTY-ONE THOUSAND NINE HUNDRED FIFTY-TWO PESOS AND TWENTY-THREE CENTAVOS (PHP 31,952.23).** The Contractor submitted a bid quotation of **THIRTY-ONE THOUSAND NINE HUNDRED FIFTY PESOS ONLY (PHP 31,950.00).**

IV-GENERAL TERMS AND CONDITIONS

- 4. The contractor shall submit progress billing or statement of work accomplished that contains the amount due the contractor vis-a-vis the work performed pursuant to the work and financial plan;
- 5. The procuring entity shall release payments based on the payment scheme provided in the contract and only upon validation by the end user unit that the contractor has delivered or performed the outputs specified in the work and financial plan and the
