WHEREAS, the Procuring Entity under Other Maint. and Operating Expenses (50299990), intends to apply the sum of FIFTY THOUSAND PESOS (PHP 50,000.00) being the Approved Budget for the Contract (ABC) for the 1 LOT FORAGE DEVELOPMENT (PAKYAW CONTRACT) FOR LGU-KAPALONG, DDN, by virtue of the Purchase Request No. 2022106768 the bidding was conducted for the purpose through Infrastructure Project Agreement governed by Republic Act 9184 otherwise known as "The Government Procurement Reform Act";

NOW THEREFORE, for and in consideration of the foregoing premises, the parties hereto agreed, as by these presents, do hereby agree to be bound by the following terms and conditions, to wit:

I-CONTRACT

This agreement is an infrastructure project between the **PROVINCIAL GOVERNMENT OF DAVAO DEL NORTE** and **MAHAYAHAY INTEGRATED FARMERS ASSOCIATION with** approved project pursuant to **PR No. 2022106768**, hereinafter called the "Infrastructure Project".

The project consists of **1 LOT FORAGE DEVELOPMENT (PAKYAW CONTRACT) FOR LGU-KAPALONG, DDN.** Progress billing will be set on percentage of completion of the growth performance of the legume & grasses planted.

II-DURATION

The intended work duration is **TEN (10) CALENDAR DAYS**, from the time the Notice to Proceed was issued by the Procuring Entity and received/acknowledged by the Contractor.

III-CONTRACT PRICE

The Provincial Government of Davao del Norte has an Approved Budget of the Contract (ABC) of **FIFTY THOUSAND PESOS (PHP 50,000.00)**. The Contractor submitted a bid quotation of **FIFTY THOUSAND PESOS (PHP 50,000.00)** based on the **Purchase Order No. 2022125853**.

- 3. Advance payment may be released in an amount not exceeding fifteen percent (15%) of the total contract price provided it is included in the contract;
- 4. The contractor shall submit progress billing or statement of work accomplished that contains the amount due the contractor vis-a-vis the work performed pursuant to the work and financial plan;
- 5. The procuring entity shall release payments based on the payment scheme provided in the contract and only upon validation by the end user unit that the contractor has delivered or performed the outputs specified in the work and financial plan and the same has been inspected and accepted by the community and confirmed by the
