WITNESSETH THAT:
WHEREAS , the Procuring Entity is a local government unit mandated to provide infrastructure facilities to service the needs of the residents of the province and which funded out of provincial funds including, but not limited to, provincial roads and bridges; intermunicipal waterworks, drainage and other similar facilities;
WHEREAS, pursuant to Section 53.12 of IRR of RA 9184 and GPPB Resolution No. 03-2013 dated January 21, 2013, it recognize the Community Participation and authorize the Procuring Entity to grant the rural community-based contractors in the procurement of goods and services and simple infrastructure projects through negotiated agreement particularly the rural road maintenance in some areas of the Province of Davao del Norte;
WHEREAS, the Procuring Entity under General Fund CY 2022, intends to apply the sum of ONE HUNDRED NINE THOUSAND ONE HUNDRED SEVENTY PESOS AND THIRTEEN CENTAVOS (PHP 109,170.13) being the Approved Budget for the Contract (ABC) for the Contract — Community Based Road Maintenance Contracting (CBRMC) and the bidding was conducted for the purpose of maintaining various Provincial Roads and Bridges — JCT. HIGHWAY CANATAN — JCT. HIGHWAY MAGATOS, governed by Republic Act 9184 otherwise known as "The Government Procurement Reform Act";
WHEREAS, upon the opening of negotiated procurement and after proper evaluation of the criteria and standards set forth by law, the Bids and Awards Committee (BAC) through BAC Resolution No. 151, series of 2022, resolved to declare the Contractor as the Single Calculated and Responsive Bidder to undertake the afore-cited Project;
WHEREAS, the Contractor is willing to undertake and implement the project in the manner provided under this contract, existing laws and/or upon the request by the Procuring

Entity.

The procuring entity shall release payments based on the payment scheme provided in the contract and only upon validation by the end user unit that the contractor has delivered or performed the outputs specified in the work and financial plan and the same has been inspected and accepted by the community and confirmed by the procuring entity as satisfactory in accordance with the technical specifications or scope of work;
- 6. The procuring entity shall conduct visit and examination for the project;
- 7. Payments and release of funds shall be subject to government auditing and accounting rules and regulations.
