WHEREAS, pursuant to Section 53.12 of IRR of RA 9184 and GPPB Resolution No. 03-2013 dated January 21, 2013, it recognize the Community Participation and authorize the Procuring Entity to grant the rural community-based contractors in the procurement of goods and services and simple infrastructure projects through negotiated agreement particularly the rural road maintenance in some areas of the Province of Davao del Norte;

WHEREAS, the Procuring Entity under Repair and Maintenance- Infrastructure Assets (50213030), intends to apply the sum of NINETY THOUSAND EIGHT HUNDRED FOUR PESOS AND FORTY-FOUR CENTAVOS (PHP 90,804.44) being the Approved Budget for the Contract (ABC) for the Contract — Community Based Road Maintenance Contracting (CBRMC) and the bidding was conducted for the purpose of maintaining various Provincial Roads and Bridges — 11DAN133 — PANTARON - MUGAS, governed by Republic Act 9184 otherwise known as "The Government Procurement Reform Act";

WHEREAS, upon the opening of negotiated procurement and after proper evaluation of the criteria and standards set forth by law, the Bids and Awards Committee (BAC) through BAC Resolution No. 415, series of 2022, resolved to declare the Contractor as the Single Calculated and Responsive Bidder to undertake the afore-cited Project;

WHEREAS, the Contractor is willing to undertake and implement the project in the manner provided under this contract, existing laws and/or upon the request by the Procuring Entity.

NOW THEREFORE, for and in consideration of the foregoing premises, the parties hereto agreed, as by these presents, do hereby agree to be bound by the following terms and conditions, to wit:

I-CONTRACT

This agreement is an infrastructure project between the PROVINCIAL GOVERNMENT OF DAVAO DEL NORTE and KATIPUNAN PANTARON IRRIGATORS ASSOCIATION INC. with approved project pursuant to PR No. 2022010168, hereinafter called the "Community-Based Road Maintenance Contract".

The project consists of Contract – Community Based Road Maintenance Contracting (CBRMC) for the maintenance of various Provincial Roads and Bridges – 11DAN133 – PANTARON - MUGAS.

Progress billing will be made within the quarter.

II-DURATION

The intended project should be done **within two (2) quarters** from the time the Notice to Proceed was issued by the Procuring Entity and received/acknowledged by the Contractor.

III-CONTRACT PRICE

The Provincial Government of Davao del Norte has an Approved Budget of the Contract (ABC) of NINETY THOUSAND EIGHT HUNDRED FOUR PESOS AND FORTY-FOUR CENTAVOS (PHP 90,804.44). The Contractor submitted a bid quotation of NINETY THOUSAND EIGHT HUNDRED ONE PESOS ONLY (PHP 90,801.00).
