UY**, hereinafter referred to as the **PROCURING ENTITY**;

Buan, Asuncion, Davao del Norte, duly represented by its Chairperson, **EDGARDO I. TABAG SR.**, hereinafter referred to as the **CONTRACTOR.** 

#### **WITNESSETH THAT:**

**WHEREAS,** the Procuring Entity is a local government unit mandated to provide infrastructure facilities to service the needs of the residents of the province and which funded out of provincial funds including, but not limited to, provincial roads and bridges; inter-municipal waterworks, drainage and other similar facilities;

**WHEREAS,** pursuant to Section 53.12 of IRR of RA 9184 and GPPB Resolution No. 18-2021 dated October 22, 2021, it recognizes the Community Participation and authorize the Procuring Entity to grant the rural community-based contractors in the procurement of goods and services and simple infrastructure projects through negotiated agreement particularly the rural road maintenance in some areas of the Province of Davao del Norte;

WHEREAS, the Procuring Entity through Repairs and Maintenance of Provincial Roads — Dist. 1 — Repairs and Maint. — Infrastructure Assets (50213030), intends to apply the sum of ONE HUNDRED TWENTY-TWO THOUSAND NINE HUNDRED FIFTY-FOUR PESOS AND FIFTY CENTAVOS (PHP 122,954.50) being the Approved Budget for the Contract (ABC), COMMUNITY BASED ROAD MAINTENANCE CONTRACTING (CBRMC) CY 2024 — SAUG — SONLON — BDRY. LONGANAPAN governed by Republic Act 9184 otherwise known as "The Government Procurement Reform Act";

WHEREAS, upon the opening of negotiated procurement and after proper evaluation of the criteria and standards set forth by law, the Bids and Awards Committee (BAC) through BAC Resolution No. 76, series of 2024, resolved to declare the Contractor as the Single Calculated and Responsive Bidder to undertake the afore-cited Project;

#### I-CONTRACT

This agreement is an infrastructure project between the **PROVINCIAL GOVERNMENT OF DAVAO DEL NORTE** and **BUAN INTEGRATED FARMERS ASSOCIATION** with approved project pursuant to **PR No. 2024010738**, hereinafter called the "Community-Based Road Maintenance Contract".

The project consists of **COMMUNITY BASED ROAD MAINTENANCE CONTRACTING (CBRMC) CY 2024 – SAUG – SONLON – BDRY. LONGANAPAN.** 

Progress billing will be made every quarter.

### **II-DURATION**


The intended project should be done **within two (2) quarters** from the time the Notice to Proceed was issued by the Procuring Entity and received/acknowledged by the Contractor.

## III-CONTRACT PRICE

The Provincial Government of Davao del Norte has an Approved Budget of the Contract (ABC) of **ONE HUNDRED TWENTY-TWO THOUSAND NINE HUNDRED FIFTY-FOUR PESOS AND FIFTY CENTAVOS (PHP 122,954.50).** The Contractor submitted a bid quotation of **ONE HUNDRED TWENTY-TWO THOUSAND NINE HUNDRED FIFTY-FOUR PESOS (PHP 122,954.00).**

- 3. Advance payment may be released in an amount not exceeding fifteen percent (15%) of the total contract price provided it is included in the contract;
- 4. The contractor shall submit progress billing or statement of work accomplished that contains the amount due the contractor vis-a-vis the work performed pursuant to the work and financial plan:
