6. Payment shall be made by the **PEEDO - DDN Hospital (Kapalong Zone)** within **20** calendar day/s from receipt of the **15 days** billing with complete attachments covering actual purchases.

7. The supplier shall provide immediately the following documentary requirements for the processing of payment, viz:


