



INVITATION TO BID FOR INFRASTRUCTURE PROJECTS

- 1 The Provincial Government of Davao Del Norte, through STIMULUS Funds 2018 and LDRRM - Trust Fund intends to apply the sum of Nine Million Ninety Six Thousand Eight Hundred Forty Seven and 99/100 Pesos (Php 9,496,847.99) and being the Approved Budget for the Contract (ABC) to p the contract with Project ID/PR Nos. 1806-2291 and 1806-2484. Bids received in excess of the ABC shall be automatically rejected at bid opening.

- 2 The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3 The prospective bidder must have completed a Single Largest Completed Contract(SLCC) that is similar to the contract to be bid, and whose value, adju prices using the PSA consumer price indices, must be at least fifty percent (50%) of the ABC to be bid: Provided, however, That contractors under Small categories without similar experience on the contract to be bid may be allowed to bid if the cost of such contract is not more than the Allowable Range o (ARCC) of their registration based on the guidelines as prescribed by the PCAB. The description of an eligible bidder is contained in the Bidding Documents, Section II. Instructions to Bidders.
- 4 Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules a (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".
Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstandir belonging to citizens of the Philippines.
- 5 Interested bidders may obtain further information from Provincial Government of Davao del Norte and inspect the Bidding Documents at the address giv 8am to 5pm.
- 6 **A complete set of Bidding Documents may be acquired by interested Bidders on July 18, 2018 to August 06, 2018 from the address below and upo nonrefundable fee for the Bidding Documents pursuant to Provincial Tax Ordinance No. 2017-001.**
It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website o Entity, provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids
- 7 The Provincial Government of Davao Del Norte will hold a **Pre-Bid Conference** on **July 26, 2018** at **9:00 a.m. at the Provincial General Services Office Con 2F PGSO Bldg., Government Center, Mankilam, Tagum City, Davao del Norte** which shall be open to all interested parties.
- 8 **Bids must be delivered to the address below on or before August 07, 2018 at 10:00 in the morning at Procurement Planning and Purchasing Section, 2 Building, Government Center, Mankilam, Tagum City.** All bids must be accompanied by a bid security in any of the acceptable forms and in the amour Clause 16 or Bid Securing Declaration pursuant to GPPB Resolution No. 03-2012.
- Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
